Piggott dropped his persuader in the early stages of a race at Deauville in 1979 but with victory still a possibility with 200m to run, he decided to improvise. As he passed the horse in second, he reached out and snatched rider Alain Lequeux's whip. Piggott was able to give his mount a few cracks with his newlyacquired shillelagh but he couldn't reel in the leader. When questioned by stewards, Piggott noted that Lequeux "didn't need it". That excuse didn't exactly wash with officials who relegated Piggott and his steed to third.

Bad, Bad Day -Tshepiso Moagi

Work-rider Moagi had a dreadful day at Turffontein on 14 May. In the first race he was charged with a contravention of Rule 58.10.2 in that he struck the horse Freely Forever more than three times in consecutive strides in the closing stages. Then in the fifth race he was charged with a contravention of Rule 62.2.7 in that as the rider of Zoo Alley he failed to ensure that he did not cause interference to Game Plan when he shifted in at approximately the 1400m. He was suspended from riding in two Work Riders' races. In the sixth race he was charged with Rule 62.2.3 - for failing to ride the horse Wall Of Ice out to the end of the race. He was again suspended from riding in one



Work Riders' race. In the eighth was charged with e offence for failing to ride the horse Nasmyth out to the end of the race. He got a further ban of one Work Riders' race.

The strong PE rider was charged at Fairview on 6 May with a contravention of Rule 61.5.7 - In that he committed a misdemeanour at the start by making unnecessary noise whilst complaining to the Assistant. He was given a warning.

HITCHING A RIDE - ANTHONY ANDREWS

The Cape jockey was charged at Scottsville on 1 May with a contravention of Rule 61.3.6 - In that he dismounted Princess Royal en route to the start and obtained a ride in the ambulance which resulted in this horse being led riderless to the start. Andrews was fined R1000.

Downing A Lion – Craig Zackey & Raymond Danielson

The two promising riders were both stood down at Turffontein on Sunday after undergoing breathalyser

undergoing breathalyser tests. The Equus Award winning Zackey was replaced on his first ride after travel complications. The two had ridden at Fairview on Friday and Greyville on Saturday. Inquiries will be held. Hopefully they will ensure that they don't do that again.



Cape Workriders

We realise they don't get much race practice but anybody who punts on anything involving these guys needs nerves of steel and a sense of humour! The first race at Kenilworth on Saturday was a comedy of errors and somehow the odds-on favourite Peonie Rock (Ndlele) landed up winning. This was despite his jockey taking things ridiculously easily in the last 50m – to win by a neck! Workrider Gwampa lost his stirrups on second favourite Trippvilia without any bumps at the start and as he was under starters orders, punters did their cash in cold blood.

STRAIGHTSHOOTER – ANTON MARCUS

In an industry where most are fearful of speaking out and from the heart it is encouraging to see that Anton Marcus expressed his reservations about the Greyville turf surface on Daily News day.
