(Trainer)- Rule 10.5.16.1 - For having in his possession a schedule 5 medication (ACEPROMAZINE) without it being properly prescribed or recorded by a Veterinary Surgeon. Fined R2500

KENILWORTH RACECOURSE - RACE 7 - 19.12.2020

L J FERRARIS

(Jockey) - Rule 62.2.7 - For, as the rider of MALMOOS, he failed to ensure that he did not cause interference to RASCALLION and CONTACT ZONE when he shifted out at the 250m. Suspended from riding in races for a period of ten (10) days from 10.01.2021 to 19.01.2021, both days inclusive.

VAAL RACECOURSE - RACE 6 - 05.01.2021

J GATES

(Apprentice Jockey)- Rule 62.2.7 - For, as the rider of IDEAL ANGEL, he failed to ensure that he did not cause interference to MAZARI when he shifted out at the 600m. Suspended from riding in races for a period of seven (7) days from 13.01.2021 to 19.1.2021

(Jockey) - Rule 58.10.2 (read with Guideline M on the use of the crop) - For striking ROSSO MEADOW more than twelve times in the entire race. Fined R2000

KENILWORTH RACECOURSE - RACE 4 - 02.01.2021

A MARCUS

(Jockey)- Rule 66.4 (read with Guideline 1 on overweight) In that he weighed in at 56.1kg, which was more than 1kg at which he weighed out. Fined R1000

TURFFONTEIN RACECOURSE - RACE 1 - 20.10.2020

C MAUJEAN

(Jockey)- Rule 62.2.2.- For, as the rider of PUERTO MANZANO, he changed his crop into his left hand at about the 150m and struck PUERTO MANZANO (ARG) to which this gelding clearly responded and he then changed his crop back into his right hand, for no apparent reason and this resulted in a pause in his riding of the gelding, and thereafter the vigour with which he rode PUERTO MANZANO (ARG) up

until about the 75m, after this gelding had responded to the use of the crop in his left hand, (as stated above), was not to the standard expected of a competent and professional Jockey. Fined the sum of R60 000, of which R30 000 is suspended for a period of 12 months, provided that Jockey Maujean is not found guilty of a contravention of this rule during that 12-month period. Inquiry Review Board set aside both the finding and the penalty imposed.

(Jockey) - Rule 58.10.2 (read with Guideline M on the use of the crop) - For striking ALL IN LINE more than three times on consecutive strides. Fined R750 $\,$

N PATEL

(Jockey) - Rule 62.2.7 - For, as the rider of TWICE GOLDEN, he failed to ensure that he did not cause interference to NIMCHA (L Hewitson), WEALTHY (A Mgudlwa) and FAVOUR (K de Melo) in the concluding stages. Suspended from riding in races for a period of seven (7) days from 04.01.2021 to 10.01.2021, both days inclusive.

KENII WORTH BACECOURSE - BACE 8 - 02 01 2021

J M T STEWART

(Trainer) - Rule 8.3.1 - For failing to have the registered colours of the owner/s of the horse ICON KING available. Penalty: Warning

(Jockey)- Rule 58.10.2- (read with Guideline M on the use of the crop) - For striking MODE more than twelve times in the entire race. Fined R1500

PORT ELIZABETH - 19.11.2020

M L TURNER

(Trainer) - Charge one - contraventions of Rules 34.1; 72.1.7; 72.1.8 and 72.1.15 - as the the Trainer of SARK, she entered and started this horse on multiple occasions, when it was not owned by the person in whose name it was reflected under and was not registered under the owner's name that it should have been. A fine of R25 000 and that Ms Turner's licence as a trainer be cancelled - the cancellation of her licence is wholly suspended for a period of two years on condition that she is not found guilty of any contraventions of these Rules during this period and Charge two - contraventions of Rule 72.1.19 being that she conspired with an unlicensed person to commit a fraudulent and dishonest act by entering into a bloodstock transaction with a person, accepting monies from him and not registering him as an owner as required to do so. A fine of R25 000 and that Ms Turner's licence as a trainer be cancelled - the cancellation of her licence is wholly suspended for a period of two years on condition that she is not found guilty of a contravention of this Rule during this period. Inquiry Review Board determined that the Inquiry be set aside and that the matter be referred for a hearing de novo.
