## GENERAL NOTICE AMENDMENTS TO THE RULES

The National Board have in terms of Clause 16.2 of the Constitution, amended the following Rules, with effect from 1 August 2022.

The words that are in **bold** and underlined are added and the words with a strikethrough are deleted.

#### **DEFINITIONS**

- 1.1.22 EPISTAXIS the presence of any amount of blood from one or both nostrils during or immediately after running in a RACE, barrier trial, fitness trial or during training.
- 7.10 Except those REGISTRATIONS specified in RULE 32.7.7 applications for the renewal of all PRIVILEGES shall be lodged in the prescribed form, together with the prescribed fee, with the CHIEF EXECUTIVE by not later than 15 June of each year, failing which the penalties and shall qualify for a discounted fee.

  Applications received after this date shall be payable in full up to 31 July and thereafter penalties will apply. All prescribed fees payable shall be published in the RACING CALENDAR from time to time.
- 10.7 HORSES owned, whether wholly or in part, by a TRAINER or his SPOUSE shall only be trained by that TRAINER or by another TRAINER who has his training establishment outside the RACING DISTRICT in which the first mentioned TRAINER has his training establishment. with the exception that a TRAINER based in Kimberley may send HORSES owned, whether wholly or in part, by him or his SPOUSE to a TRAINER based in Gauteng or at the Vaal Training Centre and vice versa.

#### 47. PROGRAMMES

47.1.5 the date, time and place or places for the closing of entries which may be made in writing, telephonically or electronically;

#### 49. ENTRIES

49.1 All entries, scratchings, and the declaration of HORSES, RIDERS, grooms, <u>compression masks</u>, blinkers, pacifiers, tongue ties, tongue straps, sheepskin cheek pieces, earmuffs and racing plates shall be made in terms of the RULES and the RACING OPERATOR'S conditions, as published from time to time.

#### 54.2 ALTERATIONS IN THE WEIGHTS

54.14 OWNERS or TRAINERS may claim and are responsible for the claiming of an APPRENTICE and female sex allowance in any RACE, except any RACE specified to preclude APPRENTICE and female sex allowances, for the RACE MEETING concerned. The APPRENTICE allowance shall be 4Kg until the end of the RACE MEETING in which the APPRENTICE has ridden his 20th winner; thereafter the allowance shall be 2.5Kg until the end of the RACE MEETING in which the APPRENTICE has ridden his 40th winner and thereafter 1.5Kg until the end of the RACE

MEETING in which the APPRENTICE rides his 50th winner. In the case of a female APPRENTICE, the allowance shall be 4Kg until the end of the RACE MEETING in which the APPRENTICE has ridden her 20th winner; thereafter the allowance shall be 3Kg until the end of the RACE MEETING in which the APPRENTICE has ridden her 40th winner and thereafter 2Kg until the end of the RACE MEETING in which the APPRENTICE rides her 50th winner. Thereafter there shall be a permanent female sex allowance of 1.5Kg for the remainder of her riding career.

#### 58.6 HOODS, BLINKERS, PACIFIERS, NOSEBANDS, TONGUE STRAPS, EARMUFFS

- 58.6.1 When hoods, **compression masks**, pacifiers or blinkers are used, they may not be of the nature of blinders and shall be worn under the bridle, be securely fastened, and permit the HORSE to have an unobstructed view to the front.
- 58.6.2 When a HORSE is to race wearing cheek pieces, <u>compression masks</u>, blinkers, pacifiers, earmuffs, a tongue tie or tongue strap this shall be declared to the ROR by the time laid down for final declarations and the HORSE shall run so equipped unless permission to the contrary is granted by the SB.
- 68. TIME LIMITS WITHIN WHICH OBJECTIONS MUST BE LODGED AND GROUNDS FOR LODGING OBJECTIONS
  - 68.2.17 that the RIDER of the HORSE is not the RIDER that was identified at the time of weighing out as the RIDER of the HORSE in question.
  - When an OBJECTION lodged in terms of RULES 68.2.10, 68.2.13 to <u>68.2.17</u> or 68.3 is upheld, the HORSE concerned shall be disqualified from the RACE and the remainder of the HORSES shall be placed relative to the original placings declared by the judge.

#### 72. SPECIFIC OFFENCES (PROHIBITED PRACTICES)

#### 72.1 CONTRAVENTIONS

- 72.1.48 the application of **apply** thermocautery to the skin over the musculoskeletal structures to cause a counter-irritant effect.
- 72.1.49 the application of **apply** a substance to cause severe or unnecessary vesiculation of the skin and/or underlying tissues.
- 72.1.50 use on, or administer or apply to, any HORSE any therapy, method or process which involves Gene Editing or Genome Editing.

#### 91. SUSPENSIONS OF PERSONS

91.1 Any PERSON who:

91.1.3 The provisions of RULE 91.1.2 shall not be enforced if, on formal application by the person suspended or disqualified, which application must be made within 90 days of the finalisation of the appeal hearing and must particularise reasons why the penalty imposed does not comply with the laws of natural justice and/or such other applicable grounds and should set out the terms of the declaration sought, a committee consisting of a member of the LICENSING BOARD and two senior STIPENDIARY STEWARDS, has on consideration of all the facts and circumstances including all the evidence heard and procedure adopted by the SPECIFIC RACING AUTHORITY, is of the view that the procedure adopted and/or the evidence heard and/or prevailing circumstances, do not warrant the finding and/or the sanction imposed. The appointed committee may amend and/or vary and/or reduce the penalty accordingly as they deem fit in their sole discretion.

#### 96. ADMISSION OF GUILT

96.2 In respect of a written admission of guilt for a contravention of RULES 58.10.2, 62.1 or 62.2 or any of its sub-RULES, the SB or any INQUIRY BOARD may impose a suspension on a RIDER from either riding in, or from attending in RACE MEETINGS for such period as determined by the SB or the INQUIRY BOARD. for no longer than 14 DAYS.

#### 100. RACING OPERATOR LEVIES

- Should a RACING OPERATOR <u>wish to</u> object to the quantum of the annual costs to be paid to the NHA, it may, <u>within 15 days after receipt of the approved NHA budget</u>, make representation to the NATIONAL BOARD, which shall consider the objection and shall make a ruling thereon.
- Should the RACING OPERATOR be dissatisfied with such ruling, it shall within 15 days give notice of the reasons for its dissatisfaction. Within 15 days after receipt of the notice of dissatisfaction, the matter will be referred to an independent accountant, of not less than 20 years standing, for a final and binding decision on the matter. The independent accountant will be nominated by the NHA's auditors and he shall adopt such procedure and formalities for the determination of the matter as he in his sole discretion may decide.
- 100.4 Until such time as a ruling is made by the NATIONAL BOARD or determination is made by the independent accountant, the quantum as stipulated in the approved NHA budget remains applicable and shall only be adjusted, if necessary, after the ruling and/or determination.

#### **APPENDIX Q - GUIDELINES ON EPISTAXIS**

- 1. HORSES that suffer a unilateral or bilateral EPISTAXIS will be deemed to have an Exercise-Induced Pulmonary Haemorrhage (EIPH) unless a veterinary surgeon, employed by the NATIONAL HORSERACING AUTHORITY can determine with sufficient certainty and/or an endoscopic examination that the EPISTAXIS is not of pulmonary origin.
- 2. The TRAINER or PERSON responsible for the HORSE may request an endoscopic examination to be performed by a veterinary surgeon within four (4) hours of the running of the RACE, barrier trial, fitness trial or training to determine the origin of the EPISTAXIS.

- 3. Should a veterinary surgeon provide a veterinary certificate stating that the EPISTAXIS was not as a result of an EIPH, the STEWARDS may lift the suspension imposed and the cost of such endoscopic examination may be recovered from the NATIONAL HORSERACING AUTHORITY.
- 4. Should an EPISTAXIS occur in the absence of a LICENCED OFFICIAL or veterinary surgeon at any place where training, racing or breeding of HORSES takes place, the TRAINER or PERSON responsible for the HORSE shall inform the STEWARDS, in WRITING within twenty-four (24) hours of such an occurrence.
- 5. Acting in terms of Rule 93.1.1, the STEWARDS on the report of a groom, PERSON, LICENCED OFFICIAL or veterinary surgeon may suspend any HORSE which has suffered an EPISTAXIS due to EIPH in training, or after the running of a RACE for the following periods of time:
  - 5.1 First episode: sixty (60) days suspension;
  - 5.2 Second episode: one hundred and twenty (120) days suspension;
  - 5.3 Third episode: permanent suspension.
- 6. Furthermore, a HORSE after suffering an EPISTAXIS due to EIPH may return to a non-bleeder status following three (3) consecutive RACES of not suffering an EPISTAXIS.

#### APPENDIX R - GUIDELINE ON RACEDAY ENDOSCOPY PROCEDURE

The TRAINER or PERSON responsible for the HORSE may request an endoscopic examination to be performed by a veterinary surgeon on duty on racedays. Alternatively, a veterinary surgeon on duty may suggest to the TRAINER or PERSON responsible for a HORSE that such HORSE should be submitted to endoscopy in view of clinical signs displayed by such HORSE or performance. Regardless of the case, a HORSE will only be submitted to endoscopy if the TRAINER or PERSON responsible and a veterinary surgeon on duty consent to such examination.

If a finding made by the veterinary surgeon on duty warrants further investigation, a Veterinary Treatment Register will be issued to the trainer and advice will be given for such a HORSE to be referred to a private veterinary surgeon.
