HOLLYWOODBETS KENILWORTH RACECOURSE - RACE 8 - 28.04.2025	
Mrs C L Bass-Robinson	Rule 11.2.8 – As the Trainer of TRIP TO MAPUTO and BABELICIOUS, she failed to ensure that these fillies were presented to race as carded. As a consequence, TRIP TO MAPUTO had to be fitted with blinkers before proceeding to the start and BABELICIOUS, which was presented and proceeded to the start with red earmuffs, raced incorrectly equipped. Fined R10 000.

Mr A Feni	<b>VAAL RACECOURSE - RACE 7 - 29.04.2025</b>  Rule 58.10.2 (read with Guideline M on the use of the crop) – As the rider of BLURRED VISION, he misused his crop by striking this gelding more than twelve times (15) which was not warranted when considering the circumstances of the race. Suspended from riding in three (3) Workrider races on 15.05.2025. 29.05.2025 & a third date to be confirmed.
Mr A C Fortune	<b>HOLLYWOODBETS SCOTTSVILLE RACECOURSE - RACE 1 - 30.04.2025</b>  Rule 62.2.7 - As the rider of BRIGHAM, he failed to ensure that he did not cause interference to EDUCATOR (C Zackey) at the 1200m .Suspended from riding in races for a period of seven (7) days from 17.05.2025 to 23.05.2025, both days inclusive.

Mr S Mthembu	<b>VAAL RACECOURSE - RACE 8 - 29.04.2025</b>  Rule 58.10.2 (read with Guideline M on the use of the crop) – As the rider of SASHA LEE, he misused his crop by striking this filly more than twelve times (14) which was not warranted when considering the circumstances of the race. Suspended from riding in two (2) Workrider races on 15.05.2025. and 29.05.2025.
Mr S Siphika	<b>VAAL RACECOURSE - RACE 5 - 29.04.2025</b>  Rule 55.4 – In that he failed to weigh out at the correct carded weight on EUPHRATES, or at the higher weight confirmed in his engagement with the Trainer. Suspended from riding in one (1) Workrider race on 15.05.2025.

Suspended from riding in four (4) Workrider races on 15.05.2025. 29.05.2025 & two additional dates to be confirmed.
Mr I Taka	<b>HOLLYWOODBETS SCOTTSVILLE RACECOURSE - RACE 9 - 30.04.2025</b>  Rule 58.10.2 (read with Guideline M on the use of the crop) – As the rider of MISTER NIBBLES, he misused his crop by striking this gelding more than twelve times (15) which was not warranted when considering the circumstances of the race. Fined R7500.
Mr E W Webber	<b>FAIRVIEW RACECOURSE - RACE 6 - 24.04.2025</b>  Rule 58.10.3.4 – In that he was found in possession of a crop that did not meet the required standards. Specifically, the contact area (paddle) of the shaft was not smooth, contained a protrusion or raised surface, and was not fully covered with shock-absorbing material as required. A fine of R1,000 was imposed.
